1. Shivapuri Rural Municipality has allocated funds towards the Construction Work for the below mentioned Contracts. Bidding is open to all eligible Nepalese Bidders.
2. Shivapuri Rural Municipality invites sealed bids **or electronic bids** from Nepalese eligible bidders for the **Upgrading of Shivapuri Talakhu Jyamire Sallaghari Likhu Pokhare And Chisapani Tumrang Batase Road (Ch:0+000 to 4+187.44 km) And (0+000 to 3+995.19 km, 0+000 to 2+071.55 km)**, under National Competitive Bidding -Single Stage Single Envelope procedures. Only eligible bidders with the following key eligibility criteria should participate in this bidding:- Company/Firm Registration Certificate, Business Registration (License) Certificate, VAT and PAN Registration Certificate, Tax Clearance Certificate, Self-Declaration, Power of Attorney, Bid Security And Sufficient Bid Validity Period.
3. Bidders may bid for one or several contracts, as further defined in the Bidding Document. Bidders wishing to offer discounts/cross discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Bid.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Shivapuri Rural Municipality office, Sherabagar, Nuwakot (www.shivapurimun.gov.np) or **may visit PPMO e-GP website www.bolpatra.gov.np/egp.**

Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Sherabagar, Nuwakot by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 on 07-02-2019. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 07-02-2019 at the office of Shivapuri Rural Municipality, Sherabagar, Nuwakot. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **following amount mentioned below from A class Commercial bank**, which shall be valid for 30 days beyond the validity period of the bid. .
