- Shivapuri Rural Municipality invites sealed bids or electronic bids from Nepalese eligible bidders for the procurement **of construction works as per below mentioned contracts**, under National Competitive Bidding -Single Stage Single Envelope procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:- Company/Firm Registration Certificate, Business Registration (License) Certificate, VAT and PAN Registration Certificate, Tax Clearance Certificate, Self-Declaration, Power of Attorney, Bid Security And Sufficient Bid Validity Period.
- Bidders may bid for one or several contracts, as further defined in the Bidding document. Bidders wishing to offer discounts/cross discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the letter of bid.
